Thank you all for your patience through our transition process. It's been a pleasure to be a part of this beautiful community. I assure you that I will try to learn all of Montecito CDD processes as quickly as possible. Below you will find a weekly recap of the items that were covered and worked on from 8/19 – 8/25:

- Focused on the admin work before the final transaction date.
- AM & PM Community Drive through No parking violations
- Community inspection with Rusty to make sure targeted areas are taken care of. Highlighted you will see Rusty's report.
- Worked with Brevard Pools and Leak detection services to get a diagnose and updates on the pool.
 - 1. Having the pool fountains on caused splashing inside the cover resulting in water loss along with water evaporation.
 - 2. Looking around the pool and seeing white water stains led them to this conclusion. This also affected the chemical balance of the pool, requiring additional testing and adjustments.
 - 3. Pool fountains were turned off on Friday morning. During the weekend, Victor tested the water twice a day making sure that the safe and clean for swimming; 2.5 on Chlorine and 7.5 on the PH.
 - 4. Brevard pools will continue to maintain the pool on a daily basis.
 - MailChimp e-blast sent out with pool updates Pool opening August 24th.
 - Heavy rain on 8/22 causing the west controller section to be down. Insight reported this and was monitoring in case of any major issue.
 - The A/C located in the clubhouse gym had a leak. Victor extracted all the water. A vendor was contacted to have the unit serviced.
 - Tickets received regarding landscaping concerns these were answered and sent to Rusty for service.
 - Pumpstation located in Montecito was reported leaking. Hoover was contacted. Service was done.
 - Ticket was submitted to Solitude to service fountain located in Lake Coquina.
 - Actively contacting lake fountain vendors to get a third bid.
 - Assisting clubhouse visitors with questions or concerns.
 - Clubhouse, gym and pool area cleaned.

Please find below a recap of the landscaping services performed for the CDD and HOA during the past week, along with adjustments made due to weather conditions: **Tuesday:** Site visit with Kisha - CDD and Mark SF-HOA

CDD - Noted areas along the outer perimeter wall needing detail and front entrances. HOA - We cannot accommodate homeowners wanting just specific services i.e. - no mowing, just weed eating or just edging. They either need to have a full service or no service. Homeowners are coming out and leaving notes for the crews requesting these types of individual services.

- 2. Spraying pool deck and bedding areas for weeds

- 4. Final walkthrough to assess overall site conditions and address any immediate concerns
